## 6. NEWS FROM AROUND THE REGIONS

### **Australia**

The AFMW has a project underway to commemorate the female medical doctors who served in **WWI**. For the past one hundred years, the more than twenty Australian women doctors who served in WWI in England and throughout the European battlefields have largely remained invisible. Most of the Australian women doctors who went to war paid their own way to England to join organizations that enabled their participation in the war effort. Two principal such concerns were the Scottish Women's Hospital (SWH) and the Women's Hospital Corps with its Endell Street Military Hospital.

Dr. Gabrielle Casper led a contingent of female medical students from Notre Dame Medical School to **CSW** in New York to give them first hand exposure to international policy development.

### **Brazil**

Anna Maria Martits, Director, International Affairs, ABMM

The elected executive of ABMM (Brazilian Association of Medical Women) for 2016-2018 was installed in office during a ceremony held in the precincts of APM (Medical Association of the State of São Paulo) on March 12, 2016. President: Dr Fátima Regina Abreu Alves; Vice President: Dr Marilene Melo and directors for the departments.

During the ceremony there was a lecture held by Dr Alexandrina Meleiro, psychiatrist, specializing in the medical profession: "Medical Women: Management of their Careers." The ceremony was followed by a pleasant lunch.

During the same ceremony the executive of ABMM-SP (State of São Paulo Branch of ABMM) also was installed for 2016-2018. President: Dr Ivone Meinão; Vice-President Dr. Maite Sevillano. Dr. Sevillano is the Vice President-elect for Latin America for MWIA for 2016-2019 and is member of the International Scientific Committee of MWIA Vienna 2016.

During the same ceremony, many important women were honoured by ABMM-SP for International Women's Day:

Luiza Trajano: important entrepreneur and one of vice presidents of the organizing committee for the Olympics RIO 2016;

Janaina Paschoal: Lawyer, professor, one of the authors of the first lawsuits for the impeachment of the President;

Claudia Colucci: a journalist specializing in health issues;

Katia Boulos: a lawyer specializing in human rights;  
Professor Dr Miriam Sotto: Professor of Medicine.

## **France**

Dr Thi Thoï Pham, Dr Marie-Dominique Ghnassia

The General Assembly of AFFM was held on February 6<sup>th</sup> during which the President, Cecile Renson, presented the moral report of 2015 which was agreed upon unanimously, and the financial report was presented by Dr Marie-Claire Brusset, Treasurer. Francine Violette, VP in charge of the continuous formation for liberal doctors, presented the data processed during 31 Sundays in 2015. Thi Thoï Pham, France's NC, presented the MWIA's report.

For personal reasons, Dr Brusset announced that she wish to resign as Treasurer and Marie-Dominique Ghnassia, Honorary President, has been elected unanimously as new Treasurer (this is possible according to the articles of AFFM).

The General Assembly was followed by the annual scientific symposium with the topics of "Ways of rejuvenating one's face" and "Breast reconstruction." The moderator was Professor Laurent Lanteri, Head of the Department of Plastic, Reconstructive and Cosmetic Surgery at the European Georges Pompidou Hospital in Paris. The symposium was very successful.

After many years of dedicated service, Cécile Renson announced her resignation as President at the executive board meeting on March 3<sup>rd</sup>. In accordance with the regulations of AFFM, Francine Violette, Vice-President, will replace her until the general Assembly of 2017. The board will to look for solutions to achieve the objectives of the association and will maintain close relations especially with MWIA.

## **Kenya**

The Kenyan Medical women held a very successful 6<sup>th</sup> Annual Scientific Symposium on March 19<sup>th</sup>. The theme was "Current updates on HIV."

## **United Kingdom**

From the MWF website

MWF are disappointed and dismayed by the Equality Analysis undertaken by the Department of Health on the proposed junior doctor contract, released yesterday. This contract is to be imposed upon doctors in training in England from August 2016.



The analysis acknowledges that changes in the contract will disadvantage women particularly those training part time, carers and lone parents.

MWF are concerned about suggestions in the analysis that women doctors who are mothers need to seek informal childcare for the increased number of evenings and Saturdays worked. This particularly affects many doctors, predominantly women, without local family and support. Junior doctors are entitled under the Human Rights Act to a family life and under their educational contract to specialty training enabling career progression and adequate preparation for professional examinations.

The spreading of a limited number of junior doctors more thinly across seven days is not going to achieve safer care or improved training of our future specialists. It is more likely to result in women doctors stepping into specialties with less acute commitment, moving out of training or leaving medicine.

## 7. **REPORT ON CSW60**

The Commission on the Status of Women took place at UN Headquarters in New York from March 14<sup>th</sup> to 25<sup>th</sup>. ## **8. REPORT FROM MWIA'S REPRESENTATIVE TO WHO**

### **Dr. Clarissa Fabre**

The major current concern of the WHO is the escalating threat posed to global health security by the **Zika virus**. Not wanting to repeat mistakes made in the West African Ebola outbreak, the WHO was quick to raise the alarm and establish an emergency response programme.

A causal link between Zika virus in the mother and microcephaly in the newborn baby has yet to be firmly established, but remains a worrying possibility. In the countries most affected by Zika virus, 56% of pregnancies are unintended. There are many reasons for this, including poor quality sex education, poor access to contraception, high prevalence of rape, and cultural barriers that make it difficult for women to negotiate the use of contraception with their partners. The countries most affected also have widely varying laws on abortion. In El Salvador, for example, abortion is completely outlawed, and many women who have had miscarriages are serving prison sentences of up to 40 years on abortion charges.

WHO is the only international organization with legitimacy to plan and execute international responses to such emergencies. It has been suggested that in some areas it lacks the capacity and culture required. Consequently, the response unit needs a powerful director backed by an independent board which can cut through WHO's regional and national bureaucracies.

As part of a delegation of MWIA members I attended the **UN's 60<sup>th</sup> session of the Commission on the Status of Women (CSW)** in New York in March. MWIA organised a parallel event on the Role of Women Doctors in the Sustainable Development Goals by Addressing Violence against Women and Girls (VAWG), at which I was privileged to speak.

**Highlights** of the UN Conference for me were:

1. One of the **Woman of Distinction Award winners**, Bandana Rana was an inspiring speaker. She is a former journalist from Nepal, founder of Saathi, the

- national network against domestic violence, and Chair of a worldwide network of women's shelters.
2. **Presentations on Cyber violence**  
There are various types of cyber violence. For example, selling girls to the sex trade or young girls for marriage; selling body parts such as eyes, eggs, breast milk; renting wombs so that women are impregnated and give birth over and over again; bullying, harassment, stalking. Commercial sexual exploitation has moved from brothels and is much more cyber-based and clandestine. Victims are taken away by motorbike or taxi to whoever wants to exploit them.
  3. **Presentations on VAWG in the digital and technological age**  
In many countries, even in remote areas, girls have mobile phones, even though they may not have enough food to eat. They must be educated to use the technology, which can also be used to blackmail them, or to lure them from rural to urban area, to be trafficked to another country. There is an entire industry to help men spy on women, for example a website called 'Spouse Tracker.'
  4. **Huru International** is an NGO which developed, and is distributing, re-usable menstrual pads to young girls in low and middle income countries, to prevent them losing several days each month in education. This is a perfect area which MWIA could support.
  5. **Justin Trudeau, the Canadian prime minister**, who last year unveiled a cabinet with an equal number of men and women 'because it is 2015,' spoke at the conference. "I am going to keep saying loud and clear that I am a feminist until it is met with a shrug....calling myself a feminist simply means that I believe in the equality of men and women." The hour-long discussion in which he was involved was punctuated by repeated cheers and applause.

## **9. REPORT FROM EUROPEAN WOMEN'S LOBBY**

**Dr. Edith Schratzberger**

MWIA's president-elect, Professor Bettina Pfleiderer became a member of a working group: mapping sexual education in March 2016. She was actively involved in fine-tuning a questionnaire which was sent to all EWL member associations last week.

MWIA is also working with the EWL who is applying for funding for education on assisted reproductive technology. If funded, Professor Pfleiderer will be a member of the board of **CohART: Cohorts on Health in Assisted Reproduction Technology**.

## **II. OTHER ORGANIZATIONS**

### **1. World Health Organization (WHO)**

a. The Global Advisory Committee on Vaccine Safety (GACVS) of the World Health Organization recently [reviewed updated data on HPV vaccine](#). Following a systematic investigation of safety concerns raised about HPV vaccines, to date, the GACVS has not found any safety issues that would alter recommendations for the use of the vaccine.

b. **Partnership for Maternal, Child and Newborn Health** has developed a new strategic plan for 2016-2020, which has 4 strategic objectives: prioritize engagement in countries, drive accountability, focus action for results, deepen partnership.

c. **Framework Convention on Tobacco Control** has written to the Inter-American Commission on Human Rights (IACHF), stating that tobacco use undermines human rights, particularly the right to health, highlights the importance of tobacco control measures and requests that the IACHF support FCTC implementation/tobacco control.

### **2. United Nations**

a. The United Nations Trust Fund in Support of Actions to Eliminate Violence against Women is accepting applications for its 20th grant cycle (2016) from civil society organizations and government authorities. The application deadline is **4 May 2016**. The complete **Call for Proposals** detailing criteria, eligibility requirements and application guidelines is available at: <http://grants.unwomen.org/> or via the UN Women homepage.

3. The **Cervical Cancer Action Coalition (CCA)** met in London regarding “Investing in Cervical Cancer Prevention 2015-2020 (report [is on the CCA website](#)) and developed a 5 year global initiative to tackle cervical cancer in low and lower-middle income countries.
