### **1. PRESIDENT'S MESSAGE**

Dr. Atsuko Heshiki and Dr. Bong Ok Kim helped me get the birthing kits from Toronto to Kolkata.

On a personal note, I lost my mother who was my best friend all through my life. She was the first female anatomist in Korea and the third President of the Korean Medical Women's Association and a member of MWIA since 1958. I feel comfortable now with the loving condolences from my friends including MWIA sisters.

Best wishes for a Happy Holiday Season and I look forward to celebrating 2016 with you in Vienna at our 30<sup>th</sup> International Meeting July 28-31, 2016.

## 5. NEWS FROM AROUND THE REGIONS

### **Australia**

AFMW President Dr. Sharon Tivey writes in her newsletter that "I am pleased to advise that AFMW, in partnership with the Medical Women's International Association (MWIA), have been able to facilitate the delivery of 25 ultrasound machines to be used in places such as Nigeria (20 machines), Tanzania and Afghanistan. In addition, education sessions have been organised in Nigeria to facilitate better use of these machines. We hope that many women and their families benefit as a result of their doctors obtaining this equipment. AFMW hopes to continue this initiative in 2016. We are thankful for the support of MWIA with this initiative. A huge thanks to Dr Gaye Casper (NSW) who has been the lead in this.

We are also looking at another grant application to facilitate compiling a history of medical women. There are numerous non-medical supporters of such work and we hope we are successful.”

## **Brazil**

Brazil continues to host scientific meetings:

October saw the topic of Menopause and November Women in Brazilian Art: Tarsila do Amaral.

On October 23, The Regional Council of Medicine, State of São Paulo, organized a full day symposium on “Bioethics and Violence against Women.”

Dr Kyung Ah Park, President of MWIA, was one of the invited speakers. Her subject was” How can we eliminate familiar violence.” ABMM was represented by various directors such as Dra. Marilene Mello and Dra. Maite Sevillano.

The elections for the executive of 2016-2018 of ABMM were on December 10.

The new President is Fatima Regina Alves and Vice President is Marilene Melo.

We are looking forward to meeting our colleagues in Vienna in July.

## **Canada**

Three members of the Federation of Medical Women of Canada have been elected to Canada’s federal government. Dr. Hedy Fry continues to represent Vancouver Centre. Two have been appointed to the gender equal cabinet of Prime Minister Justin Trudeau. Dr. Jane Philpott is the federal Health Minister and Dr. Carolyn Bennett is the Minister for Indigenous and Northern Affairs.

## **India**

The Central Asia Regional Conference of MWIA was held in Kolkata, India on December 5-6, 2015. The previous one was held at Chang Mai, Thailand, in October 2012.

It was hosted by the West Bengal Branch of the Association of Medical Women in India, which was founded in 1907. The MWIA was well represented by the President, Dr. Kyung Ah Park, Past President, Dr. Atsuko Heshiki, Dr. Bong O Kim, Chair Scientific Committee, and Dr. Padmini Murthy, one of MWIA’s Representatives to the United Nations. Dr. Amanda Owen, Medical Womens Federation National Coordinator, came from the UK.

There were over 150 delegates, mostly from West Bengal, in addition to 8 from Mumbai and 8 from Nagpur.

The Scientific Sessions were very well planned with excellent speakers. There were six Orations and several Guest Lectures. Dr. Park gave the Conference Oration. The subject was “Domestic Violence” and it was very well received. Dr. Usha Saraiya gave the prestigious Marie Catchatoor Oration and Thailand was selected for the Jhirad Oration. The multidisciplinary lecture programme was appreciated by all.

The social program included a wine party hosted by Dr. Saraiya and a Welcome Dinner for all the delegates from out of town. A gala dinner and entertainment program of Folk Dances from various parts of India were enjoyed by all the delegates. The International delegates were able to do sightseeing and shopping during their brief stay.

This conference created goodwill and friendship towards all MWIA Members. Dr. Park personally requested all of them to take part in MWIA activities and attend the Triennial Conference scheduled for July, 2016, in Vienna.

The AMWI wishes to thank the Executive for giving them the opportunity and the support to conduct the meeting.

Birthing Kits were presented to the Mission Hospital of Calcutta on behalf of MWIA by Drs. Park, Heshiki and Kim.

### **Georgia**

On December 12<sup>th</sup>, the Georgian Medical Women held a conference in Telavi. The topic was “Modern aspects of treatment of internal diseases.” There was also a workshop for family doctors on “New capabilities of metabolic surgery.”

### **United States**

AMWA Executive Director Dr. Eliza Chin reports that “AMWA recently co-hosted the Sex and Gender Medical Education Summit which brought together world-renowned experts in the field of sex and gender based medicine with curriculum leaders from over 100 medical institutions.

The first of its kind, this Summit was a national collaboration dedicated to engaging educational thought leaders in creating a roadmap to integrate sex and gender based evidence into medical and inter-professional education. The Summit was co-sponsored by AMWA, the Laura W. Bush Institute for Women's Health, the Mayo Clinic, the Society for Women's Health Research, Texas Tech University Health Sciences Center, the Sex and Gender Women's Health Collaborative, Verizon, Brown University Division



of Sex and Gender in Emergency Medicine, and Duke School of Medicine Office of Diversity and Inclusion.

During the summit, participants worked to: (1) Analyze the current climate of sex and gender education in medical schools, with a special focus on sex and gender based health disparities, (2) Assess curricular resources that can be utilized within medical schools or as interprofessional resources, (3) Identify facilitators and barriers to translating sex and gender difference research into evidence-based clinical practice, and (4) Determine how best to address present and future needs to bridge the gaps and disparities between sex and gender medical education and clinical practice.

The outcome of the Summit will be the creation and publication of national student competencies focusing on sex and gender based health. The overarching goal for the Summit is the establishment or adoption of dedicated sex and gender education curricula in all U.S. medical schools within the next five years.

AMWA leaders were integral in the support and planning of the Summit: AMWA Executive Director, Dr. Eliza Chin (Summit Co-Chair), AMWA President Dr. Theresa Rohr-Kirchgraber (Senior Advisory Committee), and AMWA President-elect Dr. Kim Templeton (Planning Committee). Thanks also to the many AMWA members who helped in the planning and coordination of the Summit and the outreach to medical schools across the nation.

## **6. REPORT FROM MWIA'S UN REPRESENTATIVES**

### **Dr. Satty Gill Keswani and Dr. Mini Murthy**

Drs. Keswani and Murthy have been representing MWIA at the various UN activities, including various meetings and conferences to commemorate the 70<sup>th</sup> anniversary of the UN.

In October, 2015, Dr. Murthy attended the UN @70 celebration at the NGODPI resource center. She participated in the program and gave a brief summary of the activities MWIA has been undertaking in the content of addressing MDG 4, 5 and SDG 3.

In October, 2015, Dr. Murthy represented MWIA at a Peace Concert organized by the UNDP and Mission of South Korea to the UN to commemorate the 70th anniversary of the United Nations.

MWIA has partnering with Zonta International and has sent 600 birthing kits to Malawi and Grenada.

Dr. Murthy has been working with Wigs Without Borders and has been able to ship over 300 wigs to Malawi, India and Grenada to assist survivors of breast cancer who have lost their hair.

Drs. Keswani and Murthy are organizing the MWIA parallel event at the upcoming 2016 CSW in New York in March.

## **7. REPORT FROM MWIA'S REPRESENTATIVE TO WHO**

**Dr. Clarissa Fabre**

One of our contacts at the WHO, **Dr Claudia Garcia-Moreno** was the lead author of a recent paper in the Lancet '**Addressing Violence against women: a call to action**' <http://raisingvoices.org/website/uploads/2013/02/Calltoaction.16days2014.LancetVAWSeries.pdf> It is an excellent summary of the current situation and emphasises the importance of political leadership and government investment as essential components to reducing violence against women. As doctors we are in an excellent position to approach sympathetic politicians who will raise the issue at the highest level and initiate the formation of an effective action plan. The health sector has a crucial part to play both in the prevention of and response to violence against women and children. For too long we have been uncoordinated and have largely sat on the sidelines.

The WHO has just launched the **Safe Childbirth Checklist** after a successful pilot in 29 countries, one of which was Nigeria. We are very proud that MWIA's Dr Rosemary Ogu led the pilot in several obstetric units there. The checklist was devised by the Harvard School of Public Health and was funded by the Bill and Melinda Gates Foundation. The aim is to reduce maternal and perinatal mortality. One of the UN Millenium development goals was to cut maternal mortality by 75% between 1990 and 2015. However, only a 44% reduction has been achieved. Ten countries (Belarus, Cambodia, Estonia, Kazakhstan, Lebanon, Mongolia, Poland, Rwanda, Timor-Leste, and Turkey) managed to achieve the target. Two in three maternal deaths now occur in sub-Saharan Africa, so that is where the major improvements are needed to achieve the new Sustainable Development Goal of reducing maternal mortality. An effective Safe Childbirth Checklist would be a simple and very useful tool to help achieve this.

Twenty experts convened by the Harvard Global Health Institute and the London School of Hygiene and Tropical Medicine published a report in the Lancet recommending that the WHO should be stripped of its role in declaring disease outbreaks to be an international emergency. This follows its catastrophic failure to warn the world of the dangers of Ebola in West Africa last year. The report calls for far greater accountability and transparency within global health institutions. While there is strong criticism of the WHO, the focus of the report is on shoring up its strengths while farming out crucial

decisions potentially influenced by political considerations. When to declare that an epidemic is an international emergency is one of those areas.

## **8. REPORT FROM EUROPEAN WOMEN'S LOBBY**

**Dr. Edith Schratzberger**

The Board and the Executive of the EWL met October 23-25, 2015.

Apart from finances and financial sustainability the issues at the EWL Executive meeting and at the Board meeting were violence against women and the refugee crisis in Europe with its implications for women - for instance the risk to be the subject of violence and/or sexual abuse for female refugees. The need to guarantee basic human rights was emphasized. EWL might either form a working group or a task force on the topic 'refugees in Europe.'

Another issue was the feminist summer school which was organized for the first time last summer and was a great success. There was consensus that it is extremely important to get in contact with the young generation and the 'AGORA' summer school was an excellent way to do this and was well accepted by the attending young women.

## **9. REPORT FROM THE WHO EMRO COMMITTEE MEETING**

**Dr. Mervat ElRafie**

I had the pleasure of representing MWIA at the Eastern Mediterranean Regional Committee Meeting that took place in Kuwait from October 5-8, 2015. It was a very comprehensive meeting, covering a wide variety of issues including food safety, social health insurance, universal health coverage, malaria action plan, social determinants of health, prevention and control of non-communicable disease, international health regulations, emergency preparedness, prevention of H5Na virus, prevention of viral hepatitis, polio eradication, mental health and MDGs passing onto SDGs.
